Meeting Date: 02.08.2023

1. The proceedings of the previous meeting are read out and confirmed.
2. The following is accepted unanimously as the plan of action for the year:
 - a. To initiate a methodology for implementing the teaching learning in accordance with the policies of NEP-CCFUP as provided by the University of Burdwan.
 - b. To encourage departments to conduct seminars/workshops to provide academic exposure to both students and faculty members.
 - c. Renovation of the Common Room for girls.
 - d. Extension of canteen space.
 - e. Conduct timely promotion under CAS for teachers.
 - f. To update ROA in accordance with the directions of the BCW of Hooghly District Magistrate.
 - g. Renovation of the classrooms and laboratory wing.
 - h. Complete the submission of all previous pending AQARs.
 - i. Submit IQA for the second cycle of UGC-NAAC assessment and accreditation.
 - j. Timely submission of AISHE.
3. A. It is noted that the admission in semester 1 of the ensuing session will be in accordance with the norms of NEP CCFUP. The new directions of the Dept. of Higher Education, Government of West Bengal, especially regarding the inclusion of EWS category is read out and it is decided that the seat matrix is to be prepared under the new conditions by the Admission committee to be sent to the relevant authorities.
4. It is also noted that curriculum suggested by the University of Burdwan needs adjustments in the curriculum planning. The Academic and Routine committee is requested to prepare fresh routine to accommodate the new system. The academic committee is requested to collect CO/PO/PSO and curriculum planning from all departments in accordance with the new system.
5. Dr. Sohini Ghosh as reported has been allotted a PhD student from the University of Burdwan, as co-supervisor. It is recommended by the IQAC that Dr. Ghosh may take up the responsibility without hampering her normal assignments and duties in the college.
6. The Soil Testing Unit has proved to be useful to the local agrarian community. In the light of this, it is proposed that the necessary purchases be allowed for the said Unit to continue their activities in this session too. The coordinators of the Soil Testing Unit are requested to expand the parameters and increase the number of agriculturists involved in the project.



A meeting of the IQAC of Polba Mahavidyalaya is held on 06.12.2023 in the chamber of the Teacher-in-Charge at 2.30PM.

1. The proceedings of the previous meeting are read out and confirmed.
2. It is reported that submission of AQARs are pending from the session of 2018-19 to 2022-23. In the light of this, the IQAC coordinator responds to the query of the members that under the directions received from the concerned authorities of Directorate of Public Instruction, Govt. of West Bengal and UGC-NAAC all pending AQARs will be submitted within the stipulated time. The AQAR progress is presented to the members. It is decided that IQAC will meet again in one month to approve the AQARs for presenting them to the Governing Body.
3. It had been decided that on the basis of the plan of action decided in the meeting of the IQAC dated 16.08.2022 that Memorandum of Understanding (MOU)/Linkage will be formed with other Institutions of Higher Education and Professional Institutions to encourage a culture of mutual academic development through sharing of knowledge, expertise, academic resources and personnel. On the basis of this and the proposals received from various institutions, several MOU/Linkages have already been signed. Several faculty exchange programmes have been conducted that has benefitted the students. It is decided that MOU/linkage should be extended, while ensuring that activities are held on the existing MOU/Linkages to maintain their validity.
4. It has been reported that while the laboratory space has been continuously updated, there are certain lab equipment that are yet to be acquired, in the light of this, it has been decided that the subjects with such requisition may visit laboratories in other colleges under MOU/linkage having these equipment to complete this requirement.
5. It is reported that various departments of the college have expressed their intention for organising seminars in the college to enhance the academic quality and to provide exposure to the students in the latest developments in the academia. On the basis of this, it is decided that the departments should organise one day seminars with State/National level resource persons. It is also decided that a budget would be drawn in consultation with the Finance Committee and Governing Body at the earliest to conduct these seminars.
6. It is resolved that the departments should conduct their internal assessment as per the dates specified by the academic committee. The marks should be forwarded to the coordinator of the IQAC within ten days of the completion of the examination. IQAC Coordinator is requested to complete the process of uploading the same on the portal of the University of Burdwan within the time stipulated by the University in due process.

1. The proceedings of the previous meeting is read out and confirmed.
2. A detailed reading of the AQARs of 2018-19, 2019-20, 2020-21, 2021-22 and 2022-23 is conducted by the members of the IQAC. The said AQARs are approved unanimously by the members by the IQAC, after inserting and suggesting a few alterations. 
